### WEDNESDAY, June 17th, 1868.

The Senate met pursuant to adjournment, and was called to order at 12 M. by the President pro tem.

Prayer by the Chaplain.

The roll being called, a quorum was present.

Mr. Goss offered the following resolution:

Resolved, That the names of the Senators voting for U. S. Senators, and the names of the candidates for whom they voted, be spread upon the Journal of the Senate;

Which was agreed to.

Mr. Alden, Chairman of Committee on Joint Rules, reported a set of Joint Rules, which were received, and on motion of Mr. Davidson, ordered to be printed and laid on the table.

Mr. Knight presented a petition contesting the seat of Mr. Crawford, Senator from the Seventh District, which was, upon motion of Mr. Knight, referred to the Committee on Privilege

A message was received from the Assembly announcing that the Senate resolution appointing a Joint Committee on a State Seal had been adopted by that body.

The President pro tem. appointed Messrs. Knight and Wood

as members of the Committee on the part of the Senate. Mr. Mobley moved that the Senator elect from the 18th Dis-

trict be now sworn in; Which was agreed to.

Mr. William Bradwell came forward and took the oath of office as Senator from the 18th District.

Mr. Alden moved that the Sergeant-at-Arms be authorized to have the desks of Senate Chamber repaired;

Which was agreed to.

Mr. Goss moved that a committee of five be appointed to report names of Senators for all the Standing Committees of this body, subject to the action of the Senate.

Mr. Knight moved that the appointment of Standing Com-

mittees be indefinitely postponed;

Upon which a division was called for, and resulted in yeas 15, navs none.

So the motion was passed.

Mr. Knight moved that the Senate take a recess till five minutes to twelve M., and that the Senate then re-assemble for a joint session with the Assembly;

Which was agreed to.

The Senate accordingly took a recess, and resumed its sitting

at five minutes to 12 M.

On motion of Mr. Mobley, a message was sent to the Assembly announcing that the Senate would be ready to meet the Assembly in joint session at 12 M., for the purpose of electing U. S. Senators.

At 12 o'clock M. the Senate proceeded in a body to the Assem-

bly Chamber.

The Joint Session was called to order by the President pro tem. of the Senate, who stated that the object of the joint session was the election of two U.S. Senators to fill existing vacancies.

The rolls of the two Houses were called, and twenty Senators

and forty-eight Assemblymen answered to their names.

The Journals of the two Houses were read, from which it appeared that there had been no choice of United States Senators.
