# JOURNAL OF THE FLORIDA SENATE

Friday, April 13, 1973

The Senate was called to order by Senator Firestone at 8:30 a.m. for the purpose of conducting the order of business of introduction and reference of resolutions, memorials, bills and joint resolutions pursuant to Rule 4.3.

#### INTRODUCTION

By Senator Sykes-

SB 570—A bill to be entitled An act relating to county officials; amending §§145.031, 145.041, 145.071, 145.08(1), 145.09, 145.10, 145.11, Florida Statutes, and 145.051, Florida Statutes, 1972 Supplement, as amended by §27, chapter 72-404, Laws of Florida, to provide a ten percent salary increase for certain county officials; providing an effective date.

—was read the first time by title and referred to the Committee on Ways and Means.

By Senator Lewis-

SB 571—A bill to be entitled An act relating to marine turtles; amending §370.12(1), Florida Statutes; prohibiting the taking, killing, possessing, or mutilating of green turtles or other marine turtles under a specified size on land or in coastal waters within one-half mile of the coastline; prohibiting the taking, killing, possessing, or mutilating of green turtles over that size within such area except in specified counties; providing exceptions; providing for permits for scientific, educational or exhibitional purposes; providing penalties; providing an effective date.

—was read the first time by title and referred to the Committee on Natural Resources and Conservation.

By Senator Lewis--

SB 572—A bill to be entitled An act relating to physiciantrained mobile rescue paramedics; amending §877.07, Florida Statutes, 1972 Supplement, as amended by §1, chapter 72-219, Laws of Florida, adding subsection (8) to said section; specifically extending the immunity from civil liability provided by the Good Samaritan act to such paramedics; providing an effective date.

-was read the first time by title and referred to the Committee on Judiciary.

By Senator Scarborough—

SB 573—A bill to be entitled An act relating to workmen's compensation; amending subsection (1) of section 440.12, Florida Statutes, to reduce the seven (7) day waiting period for the payment of compensation for disability to three (3) days; providing an effective date.

—was read the first time by title and referred to the Committees on Judiciary and Commerce.

By Senators de la Parte, McClain and Lane (23rd)-

SB 574—A bill to be entitled An act relating to Hillsborough County, City of Tampa; amending section 1 of chapter 26253, Laws of Florida, 1949, by increasing the amount of pension paid by said city to Dave King, repealing chapter 70-949, Laws of Florida, relating to the amount of pension to be paid said Dave King; providing an effective date.

Evidence of notice and publication was established by the Senate as to SB 574.

—was read the first time by title and referred to the Committee on Rules and Calendar.

By Senators de la Parte, McClain and Lane (23rd)-

SB 575—A bill to be entitled An act relating to Hillsborough County; providing for legal and secretarial assistants and office expenses of the legislative delegation of Hillsborough County; approving prior expenditures for such purposes; making such expenditures a county purpose; providing an effective date.

SB 576—A bill to be entitled An act relating to workmen's compensation; repealing subparagraph 3. of paragraph (c) of subsection (1) of section 440.02, Florida Statutes, eliminating the exception for agricultural labor from the definition of "employment"; providing an effective date.

—was read the first time by title and referred to the Committees on Judiciary and Commerce.

By Senator Scarborough-

SB 577—A bill to be entitled An act relating to workmen's compensation; amending subsection (1)(b)2 of section 440.02, Florida Statutes, extending coverage to all private employments of one or more; providing an effective date.

—was read the first time by title and referred to the Committees on Judiciary and Commerce.

By Senator Scarborough-

SB 578—A bill to be entitled An act relating to workmen's compensation; amending subsection (6) of section 440.02, Florida Statutes; including in the definition of "injury" damage to or loss of dentures, eyeglasses, prosthetic devices and artificial limbs; providing an effective date.

—was read the first time by title and referred to the Committee on Judiciary.

By Senator Scarborough-

SB 579—A bill to be entitled An act relating to workmen's compensation; repealing subsection (4) of section 440.09, Florida Statutes, removing the provision relative to the general reduction in pension benefits by the amount of workmen's compensation being paid; providing an effective date.

—was read the first time by title and referred to the Committees on Judiciary and Commerce.

By Senator McClain-

SB 580—A bill to be entitled An act for relief of Blake Hunt, father and natural guardian of William F. Hunt, a minor, providing for an appropriation to compensate him for personal injury and mental anguish suffered by his said minor son, William F. Hunt, as a result of the negligence of the personnel employed by the district school board of Hillsborough County; providing an effective date.

Evidence of notice and publication was established by the Senate as to SB 580.

—was read the first time by title and referred to the Committee on Ways and Means.

By the Committee on Criminal Justice-

SB 581—A bill to be entitled An act relating to criminal justice; creating sections 901.27, 901.28, 901.29, 901.30, 901.31, and 901.32, Florida Statutes, providing a definition; providing authorization to issue a notice to appear for misdemeanors or for violations of municipal or county ordinances triable in the county court; providing for an investigation; providing authorization to take person to medical facility; providing for service of notice; providing penalty for failure to appear; providing for issuance of warrant; amending sections 901.06 and 901.23, Florida Statutes, releasing the officer from the duty to take a person before a committing magistrate when a notice to appear is issued; providing for an effective date.

—was read the first time by title and referred to the Committee on Criminal Justice.

# By Senator Poston-

SB 582—A bill to be entitled An act relating to highway designation; providing that the highway constructed across the Indian and Banana Rivers in Brevard County be designated the Max K. Rodes Bridge and Causeway; authorizing and directing the department of transportation to erect markers; providing an effective date.

—was read the first time by title and referred to the Committee on Transportation.

#### By Senators Deeb and Myers-

SB 583—A bill to be entitled An act providing for review of sentences imposed by trial courts other than municipal; creating a sentence review board; providing the procedures for review; providing the powers, duties, staff, compensation and related matters with reference to the sentence review board; providing for review of criminal sentences; providing for review of errors of procedure or legality with respect to acts of the sentence review board; providing an effective date.

—was read the first time by title and referred to the Committee on Criminal Justice.

# By Senator Lewis-

SB 584—A bill to be entitled An act relating to public records; amending §119.07(1), Florida Statutes, to prohibit copying or otherwise using public records for solicitation purposes; providing an effective date.

—was read the first time by title and referred to the Committee on Governmental Operations.

## By Senator Deeb-

SR 585—A resolution requesting the President of the Senate to direct an appropriate standing committee to rewrite the apportionment law with respect to the Senate.

—was read the first time and referred to the Committee on Rules and Calendar.

## By Senator Lewis-

SB 586—A bill to be entitled An Act relating to education; establishing an adult offender educational fund to be administered by the division of community colleges to cover certain educational costs of qualified, incarcerated adult offenders under the jurisdiction of the division of corrections; providing an appropriation; providing an effective date.

—was read the first time by title and referred to the Committees on Education and Ways and Means.

### By Senator Glisson-

SB 587—A bill to be entitled An act relating to sentence review; amending subsection (1) of section 924.06, Florida Statutes, providing for a right of appeal against a sentence; providing an effective date.

—was read the first time by title and referred to the Committee on Criminal Justice.

## By Senator McClain-

SB 588—A bill to be entitled An act relating to persons exempt from jury duty; amending section 40.08, Florida Statutes, creating paragraphs (1) and (2) exempting certain persons from jury duty by reason of age and occupation; providing an effective date.

-was read the first time by title and referred to the Committee on Judiciary.
