## EXECUTIVE ORDER NUMBER 75-14 Executive Order of Suspension

WHEREAS, WILLIAM D. DOCKERTY is presently serving as a member of the Board of County Commissioners of Pinellas County, and

WHEREAS, it has been alleged by citizens of Pinellas County that the said WILLIAM D. DOCKERTY has violated the duties and public trust of his public office, and

WHEREAS, pursuant to the Constitution and laws of the State of Florida, an investigation has been made of the charges against the said WILLIAM D. DOCKERTY, and

WHEREAS, on April 8 and 9, 1975, Honorable JAMES T. RUSSELL, State Attorney in and for the Sixth Judicial Circuit of Florida, filed informations in the Circuit and County Courts of Pinellas County, Florida, charging the said WILLIAM D. DOCKERTY with various criminal violations of the laws of Florida;

NOW, THEREFORE, I, REUBIN O'D. ASKEW, as Governor, pursuant to the Constitution and laws of the State of Florida, do hereby find, determine and allege as follows:

A. That the acts and violations alleged herein all occurred during the present term of office of WILLIAM D. DOCKERTY as a "county officer" within the meaning of Section 7, Article IV, Florida Constitution (1968), to-wit:

B. That said WILLIAM D. DOCKERTY did commit the acts and violations of Florida law as alleged in the informations attached hereto and hereby incorporated in this Executive Order as allegations of facts constituting grounds for suspension under Article IV, Section 7(a), Florida Constitution.

C. That the facts alleged herein constitute the offenses of malfeasance, misfeasance, neglect of duty, commission of a felony or incompetence as such offenses are used in Section 7(a), Article IV, Florida Constitution.

D. That the interest of the residents of Pinellas County, Florida, and the citizens of the State of Florida can best be served by the immediate suspension of WILLIAM D. DOCKERTY from the public office which he now holds.

BEING FULLY ADVISED in the premises, and in accordance with the Constitution and laws of the State of Florida, the following Executive Order is hereby promulgated effective at 5:00 p.m. on April 11, 1975.

1. WILLIAM D. DOCKERTY is hereby suspended as and from the public office which he now holds, to-wit: County Commissioner, Pinellas County, Florida.

2. That WILLIAM D. DOCKERTY is hereby prohibited from performing any official act, duty or function of public office, from receiving any part or allowances, and from being entitled to any of the emoluments or privileges of public office

during the period of this suspension, which period shall be from the effective date hereof, until further executive order, or as otherwise provided by law.

#### SPECIAL ORDER

CS for SB 181—A bill to be entitled An act relating to the limitation of actions for professional malpractice; amending paragraph (a) of s.95.11(4), Florida Statutes, 1974 Supplement, to provide that an action for professional malpractice may not be brought more than four years from the date the incident giving rise to the action occurred regardless of when the cause of action is discovered or should have been discovered; providing an effective date.

—was taken up with pending Amendments 1 and 2 which were withdrawn.

Senators Gallen, Myers and Zinkil offered the following amendment which was moved by Senator Gallen:

**Amendment 3**—On page 1, strike everything after the enacting clause and insert: Section 1. Section 95.11, Florida Statutes, 1974 Supplement, is amended to read as follows:

95.11 Limitations other than for the recovery of real property. —Actions other than for recovery of real property shall be commenced as follows:

##### (4) WITHIN TWO YEARS

(a) An action for professional malpractice, *other than medical malpractice*, whether founded on contract or tort; provided that the period of limitations shall run from the time the cause of action is discovered or should have been discovered with the exercise of due diligence; provided, however, that the limitation of actions herein for professional malpractice shall be limited to persons in privity with the professional.

(b) An action for medical malpractice shall be commenced within two years from the time the incident occurred giving rise to the action, or within two years from the time the incident is discovered, or should have been discovered with the exercise of due diligence, provided, however, that in no event shall the action be commenced later than four years from the date the incident occurred giving rise to the action. An action for medical malpractice is defined as a claim for damages because of the death, injury or monetary loss to any person primarily caused by the negligent omission or commission of any act arising out of any medical, dental, or surgical diagnosis, treatment or care by any provider of health care. The limitation of actions within this subsection shall be limited to persons in privity with the professional. In those actions covered by this paragraph where it can be shown that fraudulent concealment or intentional misrepresentation of fact prevented the discovery of the injury within the four year period or where it was impossible to have discovered the injury within the four year

*period, the period of limitations is extended forward two years from the time that the injury is discovered or should have been discovered with the exercise of due diligence, but in no event to exceed seven years from the date the incident giving rise to the injury occurred; provided that in the event of such extension recovery shall be limited to reimbursement for actual expenses and costs.*

(b)(c) An action to recover wages or overtime or damages or penalties concerning payment of wages or overtime.

(e)(d) An action for wrongful death.

Section 2. This act shall take effect upon becoming law.

Senators Spicola and Gallen offered the following amendment to Amendment 3 which was moved by Senator Spicola and adopted:

**Amendment 3A**—On page 2, line 12, strike "or where it was impossible to have discovered the injury within the four year period" and on line 17, strike "; provided that in the event of such extension recovery shall be limited to reimbursement for actual expenses and costs"

**Amendment 4**—On page 2, line 8, strike "professional" and insert: provider of health care

Senators Gallen and Myers offered the following amendment which was moved by Senator Gallen:

**Amendment 5**—On page 1, line 7, strike ", to provide that an action for" and all of lines 8, 9, 10, 11, 12, 13 and after "supplement," insert the following: to exclude medical malpractice from paragraph (a); enacting paragraph (b) of s.95.11(4) to provide that actions for medical malpractice shall be commenced within two years from the time the incident occurred or the injury is discovered not to exceed four years from the date the incident occurred; providing exception when fraud or misrepresentation caused failure to discover or when discovery was impossible; providing limitation of recovery with exception; renumbering subsequent paragraphs, providing an effective date.

**Amendment 5A**—On page 1, strike lines 7, 8, and 9 and insert: failure to discover; providing an effective date.

**CS for SB 169**—A bill to be entitled An act relating to correctional reorganization; creating s.20.315, Florida Statutes, to create a Department of Corrections; providing for the internal structure of the department; providing for adult corrections district advisory councils; transferring the Division of Corrections, the Vocational Training Advisory Council of the Department of Health and Rehabilitative Services and the functions of the Parole and Probation Commission relating to the supervision of parolees and probationers to the new department; amending s.20.32(1), Florida Statutes, redesignating the Parole and Probation Commission as the Parole Commission and providing its powers; adding s.110.051(2)(n), Florida Statutes, to exempt specific positions from the career service; providing duties of the Department of Administration; providing certain duties of the Department of Corrections; providing for discharges from commitments; providing for commitments; providing duties of the Department of Health and Rehabilitative Services; providing for continuing effectiveness of specified rules; providing severability; adding s.921.231(4), Florida Statutes, 1974 Supplement; providing requirements for nonconfidential portion of presentence investigation reports; amending s.944.024(1), Florida Statutes, 1974 Supplement; providing a procedure for the performance of pretrial investigations; amending s.945.10(4), Florida Statutes, 1974 Supplement; providing for cooperation of the Department of Corrections, the Department of Health and Rehabilitative Services, and the Parole Commission; providing for information on released felons by the Parole Commission; repealing s.947.081, Florida Statutes, relating to the Department of Community Services of the Parole and Probation Commission; providing an effective date.

Section 18. Section 945.025(3), Florida Statutes, 1974 Supplement, is amended to read:

945.025 Jurisdiction of division.—

(3) There shall be other correctional facilities, including detention facilities of varying levels of security, work-release facilities, and community correctional facilities, half-way houses, and other approved community residential and nonresidential facilities and programs; provided that no correctional facility shall be established by changing the use and purpose of any mental health facility or institution under the jurisdiction of any state agency or department without prior approval of the legislature. Any facility, the purpose and use of which was changed prior to April 1, 1975, shall be returned to its original use and purpose by April 1, 1977, and any facility, the purpose and use of which was changed subsequent to April 1, 1975, shall be returned to its original use and purpose within 30 days after the effective date of this act. Any community residential facility may be deemed a part of the state correctional system for purposes of maintaining custody of offenders, and for this purpose the division may contract for and purpose the services of such facilities.

(a) *The Division of Parole, Probation, and Correctional Services shall be responsible for the statewide supervision of all service programs of the department, including the coordination and provision of all services in parole and probation supervision, intake, case management, diagnosis and evaluation, classification, and the management of all institutional and noninstitutional community residential and community non-residential programs of the department. However, the director shall delegate as much authority for the administration of service programs within the districts as possible to the district administrators.*

Each district program manager shall serve at the pleasure of the district administrator.*

All orders which are directed to such officer or employee shall be served upon the secretary of the Department of Corrections. Any officer or employee who, after due notice, willfully violates the lawful order of the commission, as provided herein, may be suspended and removed if he is an officer or, if he is an employee, he shall be discharged from employment.
