Howard Tommie, chairman of the Florida Seminole Tribe, introduced tribe members in costume, and James Billie, business manager for the tribe, gave a brief description of the changing styles in Indian clothing from the 1700's to the present.

Buffalo Tiger, chairman of the Florida Miccosukee Tribe, introduced Mrs. Peggy Barnett, Health Coordinator/Director of the Miccosukee Tribe, who narrated a slide presentation on Indian lore.

Chairman Tommie presented an Indian jacket to Senator Trask who accepted on behalf of the President. Chairman Tiger presented a Miccosukee tribal flag to Senator Trask who accepted on behalf of the Senate.

The President Pro Tempore thanked all the participants for the program. The Fife and Drum Corps led the departure from the chamber as the Senate adjourned at 9:46 a. m.
