INTRODUCTION AND REFERENCE OF BILLS

FIRST READING

By Senator Bankhead-

SB 36-D-A bill to be entitled An act relating to services for persons who have alcohol-related, drug-related, or mental-health-related problems; amending s. 394.65, F.S.; redesignating "The Community Alcohol. Drug Abuse, and Mental Health Services Act" as "The Community Substance-Abuse and Mental-Health Services Act"; amending s. 394.66, F.S.; revising legislative intent with respect to the provision of these services; amending s. 394.67, F.S.; revising applicable definitions to conform; adding definitions; amending s. 394.675, F.S.; providing a revised system for provision of substance-abuse and mental-health services; amending s. 394.73, F.S., pertaining to joint agreements by two or more counties for providing service programs, to conform terminology; amending s. 394.74, F.S.; revising provisions concerning contracts for provision of local programs; providing for the appointment of a technical advisory committee; requiring evaluation and a report; amending s. 394.75, F.S.; revising provisions concerning district plans for providing services; amending s. 394.76, F.S.; revising provisions for financing district programs and services; amending s. 394.77, F.S., pertaining to the uniform management information and fiscal accounting systems used by providers, to conform terminology; amending s. 394.78, F.S., pertaining to standards applicable to and procedure for monitoring service providers, to conform terminology; amending s. 394.79, F.S., pertaining to the state plan for delivering and financing the system of services, to conform terminology; amending s. 394.875, F.S.; exempting the provision of certain programs and services from the requirement that they be provided by a licensed crisisstabilization unit or residential treatment facility; amending s. 394.876, F.S.; revising requirements concerning the content of applications for license under ch. 394, F.S.; providing for the effect of this act upon prior amendments to statutes amended by this act; providing an effective date.

MOTIONS TO INTRODUCE BILLS

On motion by Senator Burt, by the required constitutional two-thirds vote of the membership the following bill was admitted for introduction:

By Senator Burt-

SB 38-D—A bill to be entitled An act relating to certification of correctional and other law enforcement officers; amending s. 943.1397, F.S.; changing the waiting period before retaking an officer certification examination; providing an effective date.

—which was referred to the Committee on Corrections, Probation and Parole.

Senator Sullivan moved to introduce a bill relating to bicycle helmets. The motion failed to receive the required constitutional two-thirds vote of the membership.

Senator Diaz-Balart moved to introduce a bill relating to the Criminal Justice Training Trust Fund. The motion failed to receive the required constitutional two-thirds vote of the membership.

On motion by Senator Silver, by the required constitutional two-thirds vote of the membership the following bill was admitted for introduction:

By Senators Silver, Crenshaw, Johnson, Brown-Waite, Siegel, Williams and Crist.—

SB 40-D—A bill to be entitled An act relating to criminal penalties; creating the "Three Strikes and You're Out Act"; requiring the court to sentence a defendant to life in prison if the defendant is convicted of certain felonies involving the use of force or violence against a person and the defendant has two or more prior offenses, committed on or after a specified date, which involved the use of force or violence against a person; providing that a defendant sentenced under the act is ineligible for certain types of gain-time, conditional release, or control release; providing an effective date.
