WHEREAS, she coordinates the Health Occupations Track in the school's career-oriented course design and takes a group of senior students to Bay Medical Center each morning, where they rotate through the hospital's various departments earning high school credit while gaining hands-on experience dealing with patients, and

WHEREAS, Ms. Butler was selected as the Outstanding High School Science Teacher of the Year by the Florida Association of Science Teachers, and

WHEREAS, the presidential award also brings her school a \$7,500 National Science Foundation grant to be used under her direction over the next 3 years, NOW, THEREFORE,

WHEREAS, in the United States, more than 45,000 individuals are on the National Organ Donor Waiting List, and

WHEREAS, Florida currently has more than 1,000 individuals on the National Organ Donor Waiting List, and

WHEREAS, eight people die each day due to a lack of donated organs and tissues, and

WHEREAS, the Florida Senate recognizes the dedication, selflessness, and contributions made by donor families who choose to provide the ultimate "Gift of Life" so that others may live, NOW, THEREFORE,

Be It Resolved by the Senate of the State of Florida.

That the Florida Senate recognizes April 21 through April 27, 1996, as "Organ and Tissue Donor Awareness Week."

BE IT FURTHER RESOLVED that the Florida Senate urges all Floridians to hold family discussions and encourage family members to

become part of the Florida Organ and Tissue Donor Registry and to contribute to the Florida Organ and Tissue Donor Trust Fund to provide for a higher quality of life for others.
