I. SUMMARY:

This bill would prohibit any state agency from soliciting any pledge or authorizing or conducting any political poll, survey, index, or measurement of any kind for the purpose of evaluating or rating any candidate for public office. A state agency is defined as any official or officer in his or her official capacity, commission, authority, council, committee, department, division, bureau, board, section or other unit or entity of the executive branch of state government that receives the majority of its funding from the state. However, polls or surveys conducted by institutions of higher learning for research purposes are exempt from the provisions of this act.

This bill does not appear to have any fiscal impact on state or local governments.

II. SUBSTANTIVE ANALYSIS:

A. PRESENT SITUATION:

Section 106.17, F.S., currently provides that a candidate, political committee, or state or county executive committee of a political party may authorize or conduct a political poll, survey, index, or measurement of any kind relating to candidacy for public office so long as the candidate, political committee, or political party maintains complete jurisdiction over the poll in all its aspects.

Subsection (5) of s. 106.15, F.S., provides that a candidate shall not use the services of any officer or employee of the state during working hours in the furtherance of the candidate's candidacy.

B. EFFECT OF PROPOSED CHANGES:

The bill provides that a state agency may not solicit any pledge or authorize or conduct any political poll, survey, index, or measurement of any kind for the purpose of evaluating or rating any candidate for public office. The bill defines "state agency" for the purposes of this act as any official or officer in his or her official capacity, commission, authority, council, committee, department, division, bureau, board, section, or other unit or entity of the executive branch of state government that receives the majority of its funding from the state. However, polls or surveys conducted by institutions of higher learning for research purposes are exempt from the provisions of this act.

This act shall take effect on October 1, 1997.

VI. AMENDMENTS OR COMMITTEE SUBSTITUTE CHANGES:

The committee substitute makes three changes to HB 217:

The bill was amended to provide that officials and officers acting in other than their official capacities are allowed to engage in polling and surveying;

The bill was amended to remove the language "or adjunct or advisory thereto or any other unit of government." This change provides clarity and does not substantively effect the bill; and,

A provision was added to exempt polls or surveys conducted by institutions of higher learning for research purposes are exempt from the provisions of the bill.
