I. SUMMARY:

This legislation re-creates the Grants and Donations Trust Fund without modification, effective November 4, 2000. The Grants and Donations Trust Fund, FLAIR #11-2-339, is administered by the legislative branch. This fund was last re-created effective November 4, 1996, by Chapter 96-86, Laws of Florida.

The House substituted SB 598 for HB 1205 prior to final passage on March 15, 2000.

II. SUBSTANTIVE ANALYSIS:

A. PRESENT SITUATION:

2. BRIEF DESCRIPTION OF THE FUND'S USES OR PURPOSES:

The fund receives public and private grants and donations.

3. MAJOR SOURCES OF REVENUE FOR THE FUND:

The major sources of revenue for the fund are public and private grants and donations. According to Comptroller data, receipts to this fund for FY 1998-99 were \$3,145,077.60.

B. EFFECT OF PROPOSED CHANGES:

This bill re-creates the trust fund without modification.
