I. SUMMARY:

This legislation re-creates the Governor's Council on Criminal Justice Trust Fund without modification, effective November 4, 2000. The Governor's Council on Criminal Justice Trust Fund, FLAIR #52-2-333, is administered by the Department of Community Affairs. This fund was last re-created effective November 4, 1996, by Chapter 96-63, Laws of Florida.

The House substituted SB 492 for HB 1347 prior to final passage on March 15, 2000.

II. SUBSTANTIVE ANALYSIS:

A. PRESENT SITUATION:

1. MAJOR STATUTES THAT CONTROL THE TRUST FUND:

2. BRIEF DESCRIPTION OF THE FUND'S USES OR PURPOSES:

The fund is used to provide support staff and pass-through funding related to federal grants from the Bureau of Justice Assistance in the U.S. Department of Justice.

3. MAJOR SOURCES OF REVENUE FOR THE FUND:

The major sources of revenue for the fund are federal funds. According to Comptroller data, receipts to this fund for FY 1998-99 were \$48,594,913.75.

B. EFFECT OF PROPOSED CHANGES:

This bill re-creates the trust fund without modification.
