I. SUMMARY:

This bill renames the former "Key Largo Hammocks State Botanical Site", as the "Dagney Johnson Key Largo Hammock Botanical State Park."

According to the Department of Environmental Protection, this bill contains an insignificant fiscal impact on state funds.

B. PRESENT SITUATION:

The Key Largo Hammocks State Botanical Site is located in the City of Key Largo, Monroe County, Florida.

Dagney Johnson, a resident of Key Largo since shortly after World War II, is considered to be one of the original environmentalists in the Keys area. In the early 1960's, Ms. Johnson founded the Upper Keys Citizens Association with other concerned citizens. The Association's objectives were to preserve the Keys and to acquire as much land in preservation as possible. She eventually became President of the Association. During this time, she brought together such people as Marjorie Stoneman Douglas and Jerry Ellis.

Ms. Johnson's subsequent appointments include serving on citizen advisory boards and Land Use Planning Councils. She received special recognition as an environmental volunteer, receiving recognition from the Sierra Club for her long-term efforts.

Recently, Ms. Johnson provided support for the purchase and development of three local parks, Old Settlers Park, Friendship Park, and The Community Park. Moreover, she opposed the largest development ever proposed in the Keys, a 2,800 unit complex and successfully defeated the development efforts. The property is known and preserved as the Key Largo Hammock State Botanical Site.

C. EFFECT OF PROPOSED CHANGES:

This bill renames the former "Key Largo Hammocks State Botanical Site", as the "Dagney Johnson Key Largo Hammock Botanical State Park."

D. SECTION-BY-SECTION ANALYSIS:

**Section 1.** Renames the "Key Largo Hammocks State Botanical Site" to the "Dagney Johnson Key Largo Hammock Botanical State Park"; clarifies that the site is located in Key Largo, Monroe County, Florida.

**Section 2.** Provides that this act takes effect upon becoming a law.

III. FISCAL ANALYSIS & ECONOMIC IMPACT STATEMENT:

A. FISCAL IMPACT ON STATE GOVERNMENT:

1. Revenues:

This bill has no direct impact on state revenues.

2. Expenditures:

According to the Department of Environmental Protection (DEP), this bill requires new signage at the park and on the roadside. DEP estimates that the cost will be between \$2,000 and \$4,000. However, the park is already required to change its name, consistent with DEP's statewide effort to incorporate "State Park" in all park names.

B. FISCAL IMPACT ON LOCAL GOVERNMENTS:

1. Revenues:

This bill has no direct impact on local government revenues.

2. Expenditures:

This bill has no direct impact on local government expenditures.

C. DIRECT ECONOMIC IMPACT ON PRIVATE SECTOR:

This bill has no direct fiscal impact on the private sector.

VI. AMENDMENTS OR COMMITTEE SUBSTITUTE CHANGES:

The Committee on Local Government and Veterans Affairs met on February 6, 2001, and adopted an amendment. This amendment adds the words "State Park" to the new name.

The amendment also provides a technical correction and changes the word in the title "Hammocks" to "Hammock."

The Committee voted to adopt the bill as a Committee Substitute. The bill, as introduced, changed the name of the park from the "Key Largo Hammocks State Botanical Site" to the "Dagney Johnson Key Largo Hammocks State Botanical Site." The CS changes the title of the park to the "Dagney Johnson Key Largo Hammock Botanical State Park."
