I. Summary:

This legislation re-creates the Juvenile Justice Training Trust Fund without modification. The Juvenile Justice Training Trust Fund, FLAIR #80-2-417, is administered by the Department of Juvenile Justice. This fund was created by Chapter 98-359.

This trust fund enables the department to fund the cost of commission-approved juvenile justice training courses.
