**SUMMARY ANALYSIS**

This bill increases the borrowing power of the City of Naples Airport Authority. This act increases the amount of outstanding indebtedness on loans secured by the City of Naples Airport Authority from \$5,000,000 to \$15,000,000 at any one time. This act does not provide for an increase in ad valorem taxes for Collier County.

This bill increases the borrowing power of the City of Naples Airport Authority. This act increases the amount of outstanding indebtedness on loans secured by the City of Naples Airport Authority from \$5,000,000 to \$15,000,000 at any one time. This act does not provide for an increase in ad valorem taxes for Collier County.

The City of Naples Airport Authority was created in 1969 by chapter 69-1326, L.O.F., and has subsequently been amended by four special acts. The City of Naples Airport Authority is a dependent special district. The \$5,000,000 debt limit was established by chapter 75-451, L.O.F.

#### C. SECTION DIRECTORY:

Section 1. Amends subsection (n) of section 4 of chapter 69-1326, L.O.F., to raise the amount of outstanding indebtedness on loans secured by the City of Naples Airport Authority from \$5,000,000 to \$15,000,000 at any one time.

Section 2. Provides effective date of upon becoming law.
