SUMMARY ANALYSIS

Section 334.071, F.S., specifies that the Legislature may designate roads, bridges and other transportation facilities for honorary or memorial purposes.

HB 579 with CS proposes five honorary designations:

- That portion of Interstate 75 from the Georgia-Florida state line to the city limits of Ocala in Marion County is designated the "Purple Heart Memorial Highway;"
- That portion of U.S. 41 located in White Springs in Hamilton County is designated as the "Dr. Martin Luther King, Jr., Memorial Highway;"
- The roundabout at State Road 51 (Walker Avenue) and County Road 136 in Live Oak in Suwannee County is designated as the "Nott Circle Roundabout."
- That portion of U.S. 27 inside the city limits of Havana in Gadsden County is designated as the "Dr. Martin Luther King, Jr., Memorial Highway."
- The northbound and southbound spans of the Cedar River Bridge on State Road 21 in Duval County are collectively designated as the "Jim Deaton Memorial Bridge."
- Bridge #930470 in the City of Riviera Beach in Palm Beach County is designated as the "L. E. Buie Bridge."
- The new Rose Bay bridges on U.S. Highway 1, between the Cities of New Smyrna Beach and Port Orange in Volusia County are dedicated in honor of United States military personnel who are prisoners of war (POW's) or who are missing in action (MIA's).
- That portion of State Road 944 on N.W. 54th Street in Miami-Dade County from the west boundary of State House District 108 to U. S. 1, is designed as the "Jean-Jacques Dessalines Boulevard."
- That portion of State Road 922 on N.W. 125th Street from N.W. 7th Avenue to Griffing Boulevard in Miami-Dade County is designated as the "Toussaint L'Ouverture Boulevard."

The Florida Department of Transportation (FDOT) is directed to erect suitable markers at either end of each roadway to denote the honorary designations. The markers will cost FDOT approximately \$7,200.

HB 579 with CS does not raise any apparent constitutional issues. It takes effect upon becoming a law.

B. EFFECT OF PROPOSED CHANGES:

Section 334.071, F.S., provides for legislative designations of transportation facilities for honorary or memorial purposes, or to distinguish a particular facility. The legislative designations do not erase the current names of the facilities, nor do they require local governments and private entities to change street signs, mailing addresses, or 911 emergency telephone-number system listings. The statute requires FDOT to place a marker at each terminus or intersection of an identified road or bridge, and to erect any other markers it deems appropriate for the transportation facility.

Based on FDOT records, 969 honorary road and bridge designations have been approved since 1922, most of them by the Legislature. Some public roads and bridges have multiple or overlapping designations.

HB 579 with CS adds five honorary designations:

- Interstate 75 from the Georgia-Florida state line to the Ocala city limits in Marion County is designated the "Purple Heart Memorial Highway;"
- U.S. 41 located within White Springs in Hamilton County is designated as the "Dr. Martin Luther King, Jr., Memorial Highway;" and
- The roundabout at State Road 51 and County Road 136 in Live Oak in Suwannee County is designated as the "Nott Circle Roundabout."
- That portion of U.S. 27 inside the city limits of Havana in Gadsden County is designated as the "Dr. Martin Luther King, Jr., Memorial Highway."
- The northbound and southbound spans of the Cedar River Bridge on State Road 21 in Duval County are collectively designated as the "Jim Deaton Memorial Bridge."
- Bridge #930470 in the City of Riviera Beach in Palm Beach County is designated as the "L. E. Buie Bridge."
- The new Rose Bay bridges on U.S. Highway 1, between the Cities of New Smyrna Beach and Port Orange in Volusia County are dedicated in honor of United States military personnel who are prisoners of war (POW's) or who are missing in action (MIA's).
- That portion of State Road 944 on N.W. 54th Street in Miami-Dade County from the west boundary of State House District 108 to U. S. 1, is designed as the "Jean-Jacques Dessalines Boulevard."
- That portion of State Road 922 on N.W. 125th Street from N.W. 7th Avenue to Griffing Boulevard in Miami-Dade County is designated as the "Toussaint L'Ouverture Boulevard."

The bill directs FDOT to erect suitable markers. It takes effect upon becoming a law.

C. SECTION DIRECTORY:

Section 1: Creates an honorary designation of Interstate 75 in North-central Florida as the "Purple Heart Memorial Highway."

Section 2: Creates an honorary designation of a highway in Hamilton County as the "Dr. Martin Luther King, Jr., Memorial Highway."

Section 3: Creates an honorary designation of a road in Suwannee County as the "Nott Circle Roundabout."

Section 4: Creates an honorary designation of a road in Gadsden County as the "Dr. Martin Luther King, Jr. Memorial Highway."

Section 5: Creates an honorary designation of two bridges in Duval County as the "Jim Deaton Memorial Bridge."

Section 6: Creates an honorary designation of a bridge in Palm Beach County as the "L. E. Buie Bridge."

Section 7: Creates an honorary designation of the new Rose Bay bridges on U.S. Highway 1, in Port Orange in Volusia County in honor of U.S. military personnel who are prisoners of war (POW's) or who are missing in action.

Section 8: Creates an honorary designation of two roads in Miami-Dade County as the "Jean-Jacques Dessalines Boulevard" and "Toussaint L'Ouverture Boulevard."

Section 9: Provides this bill shall take effect upon becoming a law.

FDOT estimates the cost of each marker at \$400, so for 18 markers, the total estimated expenditure from the State Transportation Trust Fund is \$7,200 in FY 03-04. FDOT also will be responsible for any future maintenance and replacement costs, of an indeterminate amount.

IV. AMENDMENTS/COMMITTEE SUBSTITUTE CHANGES

Transportation Systems Subcommittee action

At its March 5, 2003, meeting, the Transportation Systems Subcommittee adopted without objection two amendments and one amendment to the amendment. Specifically:

- A#1 designated the northbound and southbound spans of the Cedar River Bridge on State Road 121 in Duval County as the "Jim Deaton Memorial Bridge."
- A#2 and its amendment to the amendment designated State Road 27 inside the city limits of Havana, Florida as the "Martin Luther King, Jr., Memorial Highway."

The subcommittee then voted 9-0 in favor of HB 579, as amended.

Transportation Committee action

The committee re-adopted the "Jim Deaton Memorial Bridge" amendment recommended by the subcommittee, then adopted a substitute amendment that corrected an erroneous geographic reference to "Dr. Martin Luther King, Jr., Memorial Highway" within the city of Havana, in Gadsden County, Florida. It also directed staff to correct any other technical glitches, primarily to add the appellation, "Dr." in front of Martin Luther King, Jr.'s, name as referenced in the bill.

Finally, the committee voted 20-0 in favor of HB 579, with CS.

Transportation and Economic Development Appropriations Subcommittee

At its April 11, 2003 meeting, the Subcommittee recommended one amendment without objection as follows:

- Amendment #1 designates bridge number 930470 in the City of Riviera Beach in Palm Beach County as the L. E. Buie Bridge.

Committee on Appropriations Action:

On April 21, 2003, the Committee on Appropriations passed two amendments and adopted one traveling amendment as follows:

- Amendment # 1 designates bridge number 930470 in the City of Riviera Beach in Palm Beach County as the "L. E. Buie Bridge" as recommended by the Transportation & Economic Development, Subcommittee on Appropriations.

- Amendment # 2 designates the new Rose Bay bridges on U.S. Highway 1, between New Smyrna Beach and Port Orange in honor of United States military personnel who are prisoners of war (POW's) or who are missing in action (MIA's).
- Amendment # 3 designates State Road 944 on N.W. 54th Street in Miami-Dade County to portions of U.S. 1 as the "Jean-Jacques Dessalines Boulevard" and designates State Road 922 on N.W. 125th Street to Griffing Boulevard in Miami-Dade County as the "Toussaint L'Ouverture Boulevard."
