SUMMARY ANALYSIS

This bill:

- Reserves the first \$2 million deposited into the Save the Manatee Trust Fund for the purpose of funding marine field law enforcement positions within the Fish and Wildlife Conservation Commission (FWCC), and deletes the requirement for the FWCC to solicit advisory recommendations from the Save the Manatee Committee of the Save the Manatee Club regarding the expenditure of funds;

- Reallocates revenues generated by the sale of motor fuel and other fuels at marinas to the Marine Resources Conservation Trust Fund ("MRCTF") in the FWCC. In the first year, the bill transfers \$5 million, the second year \$8.5 million, the third year \$10.9 million, and the fourth year and every year thereafter the bill transfers \$13.4 million from the MRCTF. During the first four years, a total of \$37.8 million dollars is transferred;

- Creates the Office of Boating and Waterways within the FWCC in order to consolidate into one administrative office current boating-related functions of the FWCC;

- Authorizes the FWCC to use funds in the MRCTF for boating-related activities; and

- Requires the FWCC to develop and administer a competitive grant program to support boating-related activities and confers rule-making authority on the FWCC to implement the program.

B. EFFECT OF PROPOSED CHANGES:

ISSUE: PROTECTION OF MANATEES

Present Situation

Florida Manatee (West Indian Manatee species)

The manatees found throughout Florida's rivers, estuaries, and bays are members of the West Indian manatee species and are native to Florida's coastal and riverine waters. Adult manatees typically average 8-10 feet in length and weigh an average of 1,000-1,200 pounds while the largest manatees may reach 13 feet in length and weigh over 3,500 pounds. Manatees eat a variety of aquatic plants, as much as 200 pounds per day, and are often seen near natural or artificial fresh water sources. Gestation lasts approximately 13 months and typically results in the birth of a single calf measuring 3-5 feet in length weighing approximately 65 pounds. Calves remain with their mothers for up to two years.

The manatee is listed by both the U.S. Fish and Wildlife Service and the Florida Fish and Wildlife Conservation Commission ("FWCC") as an endangered species, and has been protected in Florida since 1892. Manatees are warm-blooded and seek refuge from cold temperatures in natural springs or congregate in manmade sources of warm water such as power plants and other industrial facilities with thermal plumes. The water temperature danger level for manatees is approximately 55°F.

Manatees are killed or injured by a variety of human-related causes including collisions with watercraft, being crushed in water control gates and boat locks, and becoming entangled in fishing gear. Manatees also die as a result of exposure to harmful algal blooms such as red tide, the effects of cold water, and disease. Manatee habitat loss or degradation is also of concern, including future changes in artificial warm water refugia upon which many manatees have become dependent. However, aerial surveys conducted by the FWCC show that manatee populations have increased in recent years as follows:

Today, state manatee rules apply to approximately 298,817 acres of Florida waters with other areas being considered for protection.³ Additionally, approximately 10,058 acres are designated as federal manatee refuges or sanctuaries. Florida has significantly increased law enforcement in manatee protection areas, has developed measurable biological goals to help define recovery of the manatee population and has instituted additional public education programs to enhance manatee protections.⁴

Current state efforts to recover the population are guided by the Florida Manatee Sanctuary Act of 1978 and the federally approved Florida Manatee Recovery Plan of 2001. In addition, the manatee is protected under the federal Marine Mammal Protection Act. During the past year, increased attention was given to assessing the status of the manatee population. A workshop was convened in April that brought together experts from around the world to review the most recent manatee data. In addition, the FWC began a Biological Status Review, which included a Population Viability Analysis. Based on these most recent analyses, it appears that the total manatee population in Florida has increased over the past 30 years. In particular, strong population growth in sub-populations such as Florida's northwest coast (including Crystal River) and the upper St. Johns River, have been well documented. Population trends in other areas such as the Atlantic Coast and southwest Florida are less clear. While there is evidence that these areas have also experienced growth over the long-term, the most recent trends are cause for concern. In particular, survival rates in Southwest Florida suggest that the population may be stable or may have begun to decline in that region. Nevertheless, the FWC remains cautiously optimistic about the manatee's future in Florida. The FWCC believes that the focus of management over the past three decades--to reduce human-related injury and death, and to protect habitat--has been a major factor in realizing positive population growth. Provided that this basic approach is continued, the long-term survival of this species is promising.⁵

FWCC Law Enforcement Authority

Section 9, Article IV of the Constitution of Florida requires the Florida Fish and Wildlife Conservation Commission ("FWCC") to exercise all regulatory and executive powers of the state with respect to wild animal life, fresh water aquatic life, and marine life. FWCC wildlife officers are fully constituted peace officers with the power to make arrests for violations of any law of this state, including Florida law

regarding marine and freshwater aquatic life as well as the laws related to boating.⁶ FWCC officers are also cross-deputized to enforce federal fisheries and wildlife laws.⁷

It is the FWCC's responsibility to provide protection and enforce laws relating to all wild animal and aquatic resources of the state including threatened and endangered wildlife, fish, and marine mammals. In addition, the FWCC enforces the boating safety requirements set forth in Chp. 327, F.S., including the boating-under-the-influence-laws and laws relating to the safe and prudent operation of watercraft, in order to ensure the safe usage of our resources. In performing enforcement duties, FWCC officers patrol over 8,246 miles of tidal coastline, 12,000 miles of rivers and streams, 3,000,000 acres of lakes and ponds, and 11,000 miles of canals.⁸

The FWCC also provides general law enforcement protection by virtue of its duty to patrol in rural, semi-wilderness, wilderness, and off-shore areas where no other law enforcement agencies routinely patrol. FWCC officers also respond to a variety of emergencies including natural disasters, civil disturbances, and search and rescue missions.

The FWCC Field Operations consists of two bureaus within the Division of Law Enforcement divided into East and West Operations. The Bureau of East Operations contains the Northeast and South Regions, including a Special Enforcement Area. The Bureaus contain 887.5 positions, 711 of which are sworn positions, which are organized in military rank structure.⁹ Funding for twenty-five sworn positions was appropriated in FY 2001-02 for enhanced manatee protection.

The operating and fixed capital outlay funding as well as staff funding for the Division of Law Enforcement is outlined as follows:

The Save the Manatee Trust Fund ("STMTF")

Funding for Florida's manatee related research and management activities is provided primarily from the Save the Manatee Trust Fund ("STMTF") within the FWCC. Section 320.08058, F.S., provides for a manatee license plate and requires that the annual use fee be deposited into the STMTF and used only for the purposes set forth in s. 370.12(4), F.S. The STMTF also receives revenues from other sources, including vessel registrations fees¹¹, county annual vessel registration optional registration fees¹², interest earnings, proceeds from the sale of decals¹³, and voluntary donations¹⁴.

Section 370.12(4), F.S., requires the FWCC to annually solicit advisory recommendations from the Save the Manatee Committee affiliated with the Save the Manatee Club, as identified and recognized in Executive Order 85-19, on the use of funds from the STMTF, and specifically provides that moneys in the STMTF may be used to fund:

- an annual, impartial scientific benchmark census of the manatee population conducted by the FWCC;
- activities of public and private organizations and those of the FWCC intended to provide manatee and marine mammal protection and recovery effort;
- manufacture and erection of informational and regulatory signs;
- production, publication, and distribution of educational materials;
- participation in manatee and marine mammal research programs including carcass salvage;
- programs intended to assist the recovery of the manatee as an endangered species, assist the recovery of the endangered or threatened marine mammals, and prevent the endangerment of other species of marine mammals;
- and, other similar programs intended to protect and enhance the recovery of the manatee and other species of marine mammals.

According to the *Save the Manatee Trust Fund—Annual Report 2001-2002*, in FY 2001-2002, appropriations to, and expenditures of, the STMTF were as follows¹⁵:

The STMTF supports four program areas within the FWCC: the Division of Law Enforcement, the Bureau of Protected Species Management, the Florida Marine Research Institute, and the Office of Informational Services.

Effect of Proposed Changes

The bill amends s. 370.12(4)(a), F.S., to dedicate the first \$2 million dollars deposited into the Save the Manatee Trust Fund to fund marine field law enforcement positions within the Fish and Wildlife Conservation Commission to enforce manatee protection laws. The law enforcement positions must be assigned to perform their law enforcement duties in counties having the highest incidences of manatee deaths and injuries. Any funds remaining in the STMTF will remain available to fund programs in accordance with the current provisions of s. 370.12, F.S.

The bill also amends s. 370.12(4)(b), F.S., requiring the FWCC to submit a report to the President of the Senate and the Speaker of the House of Representatives by December 1 of each year identifying the number of additional law enforcement positions funded and a list of the counties to which the personnel were assigned. Additionally, the bill deletes from s. 370.12(4)(b), F.S., the requirement that the FWCC solicit recommendations from the Save the Manatee Club as to the use of funds in the STMTF.

In FY 2002-03, \$1,439,451 is appropriated from the STMTF for manatee related programs in the Office of Environmental Services ("OES"). According to the FWCC, the following functions of the OES will be significantly reduced unless alternative funding sources are provided by the Legislature:

- Administration of manatee rules;
- Coordination of manatee protection plans, permit reviews, and law enforcement
- Coordination of local government grants for manatee protection plan implementation;
- Coordination with federal, state, local agencies regarding manatee habitat characterization and protection;
- Manatee outreach and information distribution; and
- Reviewing sign plans by other governmental units.

In FY 2002-03, \$2,047,326 is appropriated from the STMTF for manatee research programs conducted by the Florida Marine Institute. According to the FWCC, the following functions of the Florida Marine Institute will be significantly reduced unless alternative funding sources are provided by the Legislature:

- Manatee necropsy, salvage, and rescue;
- Manatee population monitoring;
- Tracking and monitoring manatee migration and behavior;
- Assessing the physical condition of manatees statewide;
- Studying alternative approaches to education and signage to increase boater compliance;
- Mote Marine Lab outsourcing for research regarding manatee recovery.

In FY 2002-03, \$272,915 is appropriated to the Office of Informational Services, which conducts educational programs regarding manatees. According to the FWCC, this program will be eliminated or significantly reduced unless alternative funding sources are provided by the Legislature.

According to the FWCC, the Water Management Districts and Department of Environmental Protection rely on the FWCC for technical expertise in the area of manatee protection. Additionally, the U.S. Fish and Wildlife Service relies on the FWCC to provide numerous reviews of projects, implement manatee protection plans, create and implement manatee protection rules, provide information on cause of manatee deaths, locations and population distribution, and to serve on joint agency committees and task forces designed to ensure accomplishment of recovery tasks. The Florida Department of Community Affairs also relies on FWCC for assistance in reviewing comprehensive plan amendments and Developments of Regional Impacts for manatee protection purposes.

According to the FWCC, passage of this bill may result in water dependent activities becoming more regulated by federal agencies because of reduced research, management, and education efforts regarding the manatee, ultimately diminishing Florida's information base and role in influencing local and federal decisions affecting manatees. FWCC predicts that the federal role in manatee protection issues and establishing protection areas in Florida would likely increase as a result of the total substitution of law enforcement for research, management, and education programs designed to protect manatees.

ISSUE: OFFICE OF BOATING AND WATERWAYS

Present Situation

FWCC General Duties

The Florida Fish and Wildlife Conservation Commission ("FWCC") has broad statutory authority to enforce the boating laws in this state and adopt rules further regulating many aspects of boating. The FWCC's statutory authority generally includes, but is not limited to, the authority to enforce the laws and adopt regulations related to:

1. Boater safety¹⁶;
2. Boat Speed Zones for the protection of manatees¹⁷;
3. Manatee protection generally¹⁸;
4. Boater education requirements¹⁹;
5. Waterway signage²⁰;
6. Removal of derelict vessels²¹;
7. Grants of funding to local governments to improve boater access²²;
8. Closure of waterways to boating under certain circumstances²³; and
9. Oversight of the Boater Advisory Council within the FWCC²⁴.

The Boater Advisory Council does not actually regulate boating; however, the Council does provide recommendations to the FWCC on a variety of boating related matters including boater education, boating safety, and boating related facilities.

FWCC Law Enforcement Authority

Section 9, Art. Motor Fuel Tax Collection Trust Fund

Currently, the state tax rate on motor fuel is 14.1 cents per gallon and the tax on diesel fuel is 26.7 cents per gallon statewide.²⁹ Section 206.606, F.S., requires fuel tax revenues to be deposited into the Fuel Tax Collection Trust Fund and provides for the distribution of those revenues to various agencies, one of which is the Department of Transportation. The fuel tax revenues generated by recreational boaters who purchased fuel at marinas as well as other locations in the 2002-2003 FY was approximately \$37.9 million dollars, out of which the DOT received approximately \$13.2 million.

Effect of Proposed Changes

Transfer of Funds

The bill reallocates tax revenues generated by the sale of motor fuel and other fuels at marinas to the Marine Resources Conservation Trust Fund in the FWCC. This reallocation results in a corresponding reduction in the amount currently allocated to the State Transportation Trust Fund ("STTF") in the Department of Transportation. The reduction in the STTF over the first four years is estimated to be \$37.8 million, followed by a \$13.4 reduction each year thereafter. The bill specifically provides that moneys collected from the sale at marinas will be transferred to the Marine Resources Conservation Trust Fund in the following amounts:

The bill further provides that the purposes of the Marine Resources Conservation Trust Fund are expanded to include funding for:

1. Boating research,
2. Boated-related activities,
3. Law enforcement,
4. Placement of uniform waterway markers on state waters,
5. Construction and maintenance of publicly owned boating facilities directly and through grants to local governments,
6. Implementation and administration of programs related to boating safety, boating education, manatee technical avoidance, and economic development initiatives related to boating, and
7. Other activities of the Office of Boating and Waterways.

Office of Boating and Waterways

The bill amends s. 20.331, F.S., to create the Office of Boating and Waterways within the FWCC, and assigns to that Office responsibility to manage and promote the use of state waterways for safe and enjoyable boating, including: oversight and coordination of waterway markers on state waters; providing programs for boating education and boating safety; improving boating access; coordinating the removal of derelict vessels from state waters; economic development initiatives to promote boating; and coordinating the submission of state comments on boating events.

Competitive Grant Program

The bill creates s. 327.47, F.S., which directs the FWCC to develop and administer competitive grant programs to use funds transferred from the State Transportation Trust Fund to the Marine Resources Conservation Trust Fund for the:

1. Construction of public boat ramps, piers, and docks,
2. Boater education,
3. Deployment of manatee avoidance technology, and
4. Economic development initiatives to promote boating in the state.
5. New s. 327.47, F.S., also authorizes the FWCC to adopt rules pursuant to ch. 120, F.S., to administer that section.

C. DIRECT ECONOMIC IMPACT ON PRIVATE SECTOR: None.

D. FISCAL COMMENTS:

According to the *Save the Manatee Trust Fund—Annual Report 2001-2002*, revenues for the Save the Manatee Trust Fund totaled \$3,869,710 in FY 2001-2002. If the first \$2 million in STMTF funds are dedicated to law enforcement, and revenues remain stable, \$1.86 million would be available from the Save the Manatee Trust Fund to continue the manatee recovery program in the FWCC, unless the program is funded from other sources of revenue.

Additionally, the bill reallocates moneys from the Fuel Tax Collection Trust Fund to the Marine Resources Conservation Trust Fund, as opposed to the State Transportation Trust Fund for the purpose of funding boating-related activities. *Beginning in FY 2006/2007, \$13.4 million will be transferred each year directly to the MRCT, rather than to the SSTF.

III. COMMENTS

A. CONSTITUTIONAL ISSUES:

1. Applicability of Municipality/County Mandates Provision:

The bill does not affect municipal or county government.

2. Other: None.

B. RULE-MAKING AUTHORITY: Requires the FWCC to develop and administer a competitive grant program to support boating-related activities and confers rule-making authority on the FWCC to implement the program.

C. DRAFTING ISSUES OR OTHER COMMENTS: None.

IV. AMENDMENTS/COMMITTEE SUBSTITUTE CHANGES

On March 26, 2003, the Natural Resources Committee reported HB 1319 favorably with a Committee Substitute. Three amendments were adopted by the Committee, described as follows:

Amendment No. 1:

This amendment amends s. 370.12, F.S., to eliminate the requirement for the FWCC to annually solicit advisory recommendations from Save the Manatee Committee of the Save the Manatee Club regarding the use of funds in the Save the Manatee Trust Fund.

Amendment No. 2:

This Amendment amends the full text of HB 1305 onto HB 1319, and is summarized as follows:

- Transfers revenues generated by the sale of motor fuel and other fuels at marinas to the Marine Resources Conservation Trust Fund ("MRCTF") in the FWCC from the Fuel Tax Collection Trust Fund, ultimately reallocating those funds from the State Transportation Trust Fund ("SSTF") in the Department of Transportation to the FWCC;
- Creates the Office of Boating and Waterways within the FWCC to consolidate current boating-related functions of the FWCC into one administrative office;
- Requires funds in the MRCTF to be used to provide additional law enforcement on all waters of this State, for placement of uniform waterway markers on state waters, provide funding for publicly owned boat ramps and other boating facilities, and to implement and administer other boating related programs;
- Requires the FWCC to develop and administer a competitive grant program to use funds transferred to the MRCTF for the construction and maintenance of publicly owned boating facilities, boater education, manatee avoidance technology, and economic development initiatives;
- Confers rule-making authority on the FWCC to implement the competitive grant program; and
- Transfers to the MRCTF \$5 million in the first year, \$8.5 million the second year, \$10.9 million the third year, and \$13.4 million the fourth year and every year thereafter. Over the first four years, a total of \$37.8 million dollars is transferred.

Amendment No. 3:

This amendment adds language to s. 370.12, F.S., to specify that the additional law enforcement positions funded by the Save the Manatee Trust Fund are "marine field" law enforcement positions.
