An act relating to the education; provides that certain funds transferred to Education Enhancement Trust Fund may be used for recurring appropriations; revises funding model for exceptional student education programs to provide additional funds for students who are gifted in graded K through 8; provides formula for calculating supplemental allocation for juvenile justice education programs; repeals obsolete provisions limiting certain uses of proceeds from district school tax, etc.
