Your Conference Committee on the disagreeing votes of the two houses on CS Senate Bill 1124, same being:



having met, and after full and free conference, do recommend to their respective houses as follows:


1. That the House recede from its Amendment 1.
2. That the Senate and House of Representatives adopt the Conference Committee Amendment attached hereto, and by reference made a part of this report.


