having met, and after full and free conference, do recommend to their respective houses as follows:


1. That the House of Representatives recede from House Amendment 166247 to Committee Substitute for Senate Bill 20-C, and

The Conference Committee Amendment to CS/SB 20-C related to research funded by the Pari-mutual Wagering Trust Fund:


- Repeals section 1011.93, Florida Statutes, requiring that funds from the Pari-mutuel Wagering Trust Fund within the Department of Business and Professional Regulation be used for university-administered and directed research and development programs at the University of Florida.
- Provides that the bill is effective upon becoming law.


