Requires that land management plans provide short-term and long-term management goals. Provides for funds to be deposited in the Florida Forever Trust Fund, etc. Effective Date: 07/01/2008.

#### **CS/CS/SB 2212 (3R) by the Committees on General Government Appropriations, Communications and Public Utilities and the Committee on Communications and Public Utilities (Bennett)—**

**Public Service Commission;** Revises the deadline for a sitting member of the Public Service Commission to give notice of intent to seek reappointment. Renames the Committee on Public Service Commission Oversight, a standing joint committee of the Legislature, as the "Committee on Public Counsel Oversight." Deletes the committee's authority to recommend to the Governor nominees to fill vacancies on the Public Service Commission, etc. Effective Date: Upon becoming law.

#### **CS/SB 2422 (3R) by the Committee on Governmental Operations and Senator Alexander—**

**Local Government Finance;** Provides that the appointment of the executive director of the State Board of Administration be confirmed by the Senate and approved by a majority vote of the trustees of the board. Provides for the administration of the Local Government Surplus Funds Trust Fund. Provides for the establishment of a reserve account and requires monthly allocations to such account. Creates the Pool Participant Advisory Council, etc. Effective Date: Upon becoming law.

#### **CS/CS/CS/SB 392 (3R) by the Committees on Finance and Tax, Governmental Operations, Community Affairs, Senator Storms and others—**

**Transparency in Local Government Contracts;** Provides that contractual rights of local government employees and retirees who are members of the Florida Retirement System or a local government retirement system are not considered contracts. Requires local governments that have a website to electronically post contract information relating to certain contracts. Requires that access to website be provided at no cost. Establishes schedule for local govts. to meet requirements of the act, etc. Effective Date: 07/01/2008.

**CS/CS/SB 2580 (3R) by the Committees on General Government Appropriations, Environmental Preservation and Conservation, Senator Alexander and others—**

Requires that the district coordinate with regional water supply authorities and governmental partners to maximize opportunities concerning the efficient expenditure of public funds. Prohibits the permitting of landfills under certain conditions, etc. Effective Date: 07/01/2008.

**Mobile Homes Sales Tax Reimbursement/Tornadoes;** Extends a deadline for certain mobile home owners to file an application for reimbursement of sales taxes paid on mobile homes purchased to replace mobile homes damaged by a tornado. Requires that certain unexpended funds certified forward be used for the purpose of paying the reimbursements, etc. Effective Date: Upon becoming law.

**Economic Stimulus;** Requires the State Board of Administration to report on the amount and type of technology and growth investments held by each fund. Authorizes the board to invest a certain percentage of net assets in technology and growth investments. Creates the Reusable Space Vehicle Industry Prize Program within the Office of Tourism, Trade, and Economic Development of the Executive Office of the Governor, etc. Effective Date: 07/01/2008.

**CS/CS/CS/SB 2158 (3R) by the Committees on General Government Appropriations, Finance and Tax, Banking and Insurance and the Committee on Banking and Insurance (Posey)—**

Revises provisions relating to the powers of the Office of Financial Regulation and the Financial Services Commission. Revises provisions relating to examinations and investigations conducted by the office. Revises the list of prohibited acts by a money services business, etc. Effective Date: 01/01/2009.

Requires an image of the regulated metals being sold. Provides for enhanced penalties for third or subsequent violations of a specified provision. 
