Section 50. Section 718.509, Florida Statutes, is amended, and section 498.019, Florida Statutes, is transferred, renumbered as subsections (1) and (2) of that section, and amended to read:

718.509 Division of Florida ~~Land Sales,~~ Condominiums, Timeshares, and Mobile Homes Trust Fund.--~~All funds collected by the division and any amount paid for a fee or penalty under this chapter shall be deposited in the State Treasury to the credit of the Division of Florida Land Sales, Condominiums, and Mobile Homes Trust Fund created by s. 498.019.~~

18 (1) There is created within the State Treasury the Division
19 of Florida ~~Land Sales~~, Condominiums, Timeshares, and Mobile Homes
20 Trust Fund to be used for the administration and operation of
21 this chapter and chapters 718, 719, 721, and 723 by the division.

22 (2) All moneys collected by the division from fees, fines,
23 or penalties or from costs awarded to the division by a court or
24 administrative final order shall be paid into the Division of
25 Florida ~~Land Sales~~, Condominiums, Timeshares, and Mobile Homes
26 Trust Fund. The Legislature shall appropriate funds from this
27 trust fund sufficient to carry out the provisions of this chapter
28 and the provisions of law with respect to each category of
29 business covered by the ~~this~~ trust fund. The division shall
30 maintain separate revenue accounts in the trust fund for each of
31 the businesses regulated by the division. The division shall
32 provide for the proportionate allocation among the accounts of
33 expenses incurred by the division in the performance of its
34 duties with respect to each of these businesses. As part of its
35 normal budgetary process, the division shall prepare an annual
36 report of revenue and allocated expenses related to the operation
37 of each of these businesses which may be used to determine fees
38 charged by the division. This subsection shall operate pursuant
39 to the provisions of s. 215.20.
