I. Summary:

The bill deletes the requirement for school districts to designate a teacher to serve as a district representative to recommend methods to reduce paperwork and reporting burdens.

The Commissioner of Education will continuously review data and paperwork reporting required of the school districts and recommend to districts the elimination or consolidation of reporting requirements. By June 1, the Commissioner will complete an annual review and by July 1, prepare a report for this purpose.

This bill substantially amends sections 1001.42 and 1008.31 of the Florida Statutes.

II. Present Situation:

The 2005 Legislature created the Paper Reduction Task Force¹ to recommend ways to minimize the paperwork burden placed on school districts. The Paper Reduction Task Force met three

times, solicited input from educators, and collaborated to develop recommendations, two of which included:

- Requiring school districts to establish a task force to reduce the paper and electronic reporting requirements that affect school districts; and
- Requiring the DOE to review the annual reports and progress of each school district task force and, based on such information, provide its recommendations to school districts for the reduction, elimination, revision, or consolidation of paper and electronic reporting requirements.²

As a result of the Task Force recommendations, the 2006 Legislature enacted several recommendations of the task force, including the appointment of a classroom teacher to speak on behalf of paper and data reduction at the district level.³ However, implementation of those provisions has become cumbersome and may in fact result in additional paperwork burdens.⁴

In an effort to effectively address the paperwork and reporting burdens of the school districts, the Commissioner of Education has initiated a process for the continual review of data collection and reporting required of the districts with a focus on eliminating or consolidating reporting burdens or duplication of data collection. Additionally, the Department of Education will provide specific reporting information and assistance to school district so that reports and data collection activities can be streamlined, consolidated, and eliminated when possible.⁵

III. Effect of Proposed Changes:

The bill deletes the requirement for school districts to designate a teacher to serve as a district representative to gather input from colleagues and recommend methods to reduce paperwork and data reporting burdens.

Under the bill, the Commissioner of Education will review data and paperwork reporting by the school districts and recommend to districts specific data collection and reports which can be eliminated or consolidated.

The committee substitute:
