Provides criteria for awarding grants. Provides a definition. Requires grant recipients to submit an evaluation of certain activities to the department. Authorizes the department to provide technical support, etc. Effective Date: 07/01/2010.

Provides that certain services require voluntary participation by affected youth and are not intended to create an involuntary court-sanctioned residential commitment, etc. Effective Date: 07/01/2010.


