**Senate Amendment (with title amendment)**

Between lines 395 and 396  
insert:

Section 3. Paragraph (a) of subsection (1) of section 320.04, Florida Statutes, is amended to read:

320.04 Registration service charge.—

(1)(a) There shall be a service charge of \$2.50 ~~\$5~~ for each application that ~~which~~ is handled in connection with original issuance, duplicate issuance, or transfer of any license plate, mobile home sticker, or validation sticker or with transfer or duplicate issuance of any registration certificate. ~~Of that~~

13 ~~amount, \$2.50 shall be deposited into the General Revenue Fund,~~  
14 ~~and the remainder shall be retained by the department or by the~~  
15 ~~tax collector, as the case may be, as other fees accruing to~~

17 Section 4. Section 320.08046, Florida Statutes, is amended  
18 to read:

19 320.08046 Surcharge on license tax.—There is levied on each  
20 license tax imposed under s. 320.08, except those set forth in  
21 s. 320.08(11), a surcharge in the amount of \$2 ~~\$5.50~~, which  
22 shall be collected in the same manner as the license tax. Of the  
23 proceeds of each license tax surcharge, \$1 ~~\$4.50~~ shall be  
24 deposited into the General Revenue Fund and \$1 shall be  
25 deposited into the Grants and Donations Trust Fund in the  
26 Department of Juvenile Justice to fund the juvenile crime  
27 prevention programs and the community juvenile justice  
28 partnership grants program.

29 Section 5. Subsection (3) is added to section 320.203,  
30 Florida Statutes, to read:

31 320.203 Disposition of biennial license tax moneys.—

32 (3) Any registrant who was assessed biennial fees pursuant  
33 to chapter 2009-71, Laws of Florida, between September 1, 2009,  
34 and August 31, 2010, shall receive a \$6 credit for each  
35 registration, which shall be applied to the next registration  
36 period. This credit shall be deducted from moneys in the General  
37 Revenue Fund. This subsection expires September 30, 2012.
