

## Order Number B4 Online Computer Access

The online information service provides dial-up computer access to the Bill Information System and Lobbyist Registration System. Access is provided and maintained by the Office of Legislative Information Technology Services. Information is available on current and prior year for all bills prefiled in the interim and filed during regular and special sessions. Lobbyist registration information is also available for current and prior year.



Online access is obtained through use of dial-up devices. Access includes bill information regarding bill descriptions, sponsors, committee substitutes, bill references, bills in messages, various other bill related information, and lobbyist registration information.

Online access subscribers should call the **Office of Legislative Information Technology Services at (850) 488-8326** for information or assistance pertaining to terminal and equipment subscriber services. Bill information can be obtained from the **Legislative Information Services Division at (850) 488-4371**, and lobbyist registration information can be obtained from the **Lobbyist Registration Office at (850) 922-4990**.
